Present in Algiers, Boumerdès, Blida, Béjaïa, Bordj Bou Arreridj and Jijel, we operate at three of the country's main ports of entry — Algiers, Béjaïa and Djen-Djen —, at the Algiers airport cargo terminal, and at several dry ports and bonded warehouses.

Our declarations are filed on the ALCES system with tools that integrate artificial intelligence: better-prepared files, every declaration checked and secured before submission, more favourable channels.

Customs clearance is our core business. Advisory, transport and handling complete the chain — a single point of contact, from the port to your site.

Customs clearance

Import and export, under all customs procedures. Declarations on ALCES with AI-assisted tools, prior tariff study, channel monitoring through to release, on-time pickup. Pre-alert handling, tracking, insurance and survey, inspection scheduling, daily reporting and follow-up.

Advisory & Customs litigation

Pre-alert studies, regulatory assistance, appeals and dispute settlement, release of goods, penalty waivers. Requests and follow-up of tariff classification rulings with the DGD. Support in obtaining Authorised Economic Operator (AEO) status.

Transport & Logistics

Sea freight (FCL, LCL, breakbulk, RO/RO), air freight, road transport nationwide. End-to-end door-to-door solutions through our network of international partners, with continuous tracking.

Crane & Handling

Lifting, port unloading, heavy and out-of-gauge loads, transport of exceptional parts — through to installation at your production site.

Specialised formalities

- Measuring instruments: entry declaration and import visa from the OAM (formerly ONML)
- Audio/audiovisual media and products: ONDA royalty
- DCP visas (conformity), phytosanitary (plant origin) and veterinary (animal origin)
- Letters of undertaking required beforehand for shipping dangerous goods

Tax advantages & customs procedures

If your operation qualifies, we prepare the file and follow it through to the end:

Algeria–EU Association Agreement — European origin, EUR.1 certificate — exemption from customs duties

GZALE — goods of Arab-country origin, Greater Arab Free-Trade Area certificate of origin

AAPI (formerly ANDI) — investment projects — approval + equipment list

ANADE (formerly ANSEJ) — entrepreneurship — approval + equipment list

Petroleum regime — VAT exemption — Sonatrach/oil-company contract + allocation certificate

Mining regime — contract + allocation certificate

Pharmaceutical production — approval + forecast import programme (Min. of Pharmaceutical Industry)

Other customs procedures exist depending on the nature of your operation — describe your project and we will identify the applicable scheme.

Verified tariff classifications, estimated duties and taxes, required documents and authorisations — before your cargo leaves the port of departure. No unpleasant surprises on arrival.

1 Sign the mandate

Download the customs-broker mandate and appoint OM TRANS as your representative — the regulatory condition for processing your file.

2 Submit your pre-alert

Send us your pro forma invoices and product descriptions, before the goods are shipped.

3 Receive our study

Tariff classifications, estimated duties and taxes, list of required documents. You ship fully informed.
